

## APPEALS BY REPORTER

I compiled two documents which set out the decisions by different Reporters on windfarms. In both the terms “**REFUSED**” and “**ALLOWED**” refer to decisions on **appeals** while decisions on **S36** schemes are shown as “**S36 YES**” when the Report recommended approval and “**S36 NO**” when it was for refusal.
